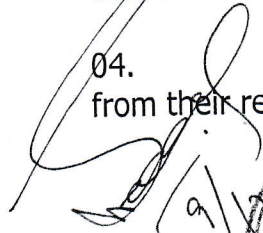

04. The Officers mentioned at Sr.No.7 to 12 above will draw salaries from their respective Departments.



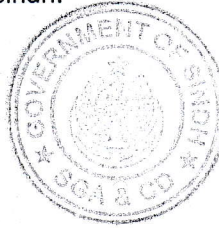
