- (ii) after Sr. No. 32, the following new entries shall be inserted:-

"32 - A. SCIENCE & INFORMATION TECHNOLOGY DEPARTMENT"

1. Implementation of National Policies/Action Plans on Science and IT.
2. Promoting, developing and implementing best practices of Digital Transformation through utilizing the concepts of Business Process Re-engineering for Departments of Government of Sindh.
3. Establishing Science Labs/Cities/Parks in collaboration with Academia and Industry through Government and/or Public Private Partnership.
4. Establishing collaboration and co-ordination with Public and Private sector organizations/industries in the field of Science and Information Technology.

5. Creating awareness amongst citizens regarding use of electronic data and scientific research through various platforms such as seminars, conferences, briefing sessions etc.
6. Developing Data Security policy and establishing firewalls for the overall management of electronic data.
7. Developing Government Websites and implementing effective standards towards monitoring Government websites.
8. Promoting E-Procurement across all Departments of Government of Sindh to increase transparency and accountability and saving public resources (time & cost) in consultation with the SPPR Authority in accordance with the provisions of the Sindh Public Procurement Act 2009 and Rules made there-under.
9. Promoting Research and Development (R&D) in all fields of Science and Information Technology and recognition of R&D achievements through awards and prizes.
10. Development of Human Resource through trainings and capacity building programs in various streams of Science and IT and taking initiatives/efforts towards the utilization of potential HR in collaboration with Government Departments and Public/Private organizations.
11. Introducing Science and IT projects/schemes with special interest in areas such as Artificial Intelligence, Cyber Security etc. under Implementation in the Province and providing extensive Monitoring and Evaluation towards successful execution of these projects.
12. Promoting E-Governance initiatives through Digitization and Automation of all processes involved across public sector in Sindh.
13. Liaison and constant engagement with MoST and MoITT for seeking guidance for provincial policy framework development and implementation.
14. Exploring funding opportunities and scholarships for schools, colleges and university students in various disciplines of Science and Information Technology.
15. Infrastructure development of IT.
16. Matters related to Sindh IT Company.
17. Service matters, except those entrusted to the Services, General Administration and Coordination Department.
