ORDER

No.SOII(SGA&CD)3-64/2025: In continuation of this Department's notification of even number dated 11th December, 2025 and in pursuance of the Finance Department's advice, vide U.O.NO.FD(SR-IV)12-204/2025 dated 19th January, 2026, the following terms and conditions are hereby allowed for appointment of **Dr. Dur-e-Naz Jamal**, retired Senior Women Medical Officer (BS-20), as Secretary, Safe Blood Transfusion Authority, on **contract basis**, for a period of **six (06) months** w.e.f. the date of issuance of appointment notification, in pursuance of decision of Provincial Cabinet meeting held on 20th November, 2025.

1.	Pay and Regular Allowances	To be entitled to receive pay and regular allowances as per last pay drawn except Orderly Allowance.
2.	Residential Accommodation	Residential Accommodation or House Rent Allowance, as the case may be, admissible to the rank of an officer of BS-20.
3.	Medical Facilities	Will be entitled for medical treatment of her-self and her dependent (eligible) family members as admissible to the rank of an officer of BS-20, with the condition that she will avail the medical re-imbursement facility either as a retired Women Medical Officer or at the current position.
4.	Leave	Will be dealt as per the Sindh Civil Servants, (Leave Rules) 1986.
5.	Conduct	Will be dealt as per the Sindh Civil Servants (Conduct) Rules, 2008.
6.	Discipline	To be governed under the Sindh Civil Servants (E&D) Rules 1973.
7.	Appeal	To be governed under the Sindh Civil Servants Appeal Rules 1980.
8.	Travelling Allowance	As admissible to the rank of an officer of BS-20 in Government of Sindh.
9.	Other Matters	Shall exercise DDO powers in accordance with the Sindh Delegation of Financial Powers and Financial Control Rules-2019.
