ORDER

WHEREAS, with the approval of Authority i.e. Chief Minister, Sindh, major penalty of "reduction in lower post for a period of one year" was imposed upon Mr. Abdul Rahim Shaikh under Rule-4(1)(b)(i) of the Sindh Civil Servants Efficiency & Discipline) Rules, 1973, on the allegations of involvement in issuance of unsigned and unstamped challans to violators during price-checking drives, rendering these documents invalid and compromising the legitimacy of enforcement efforts with the observations of significant discrepancies between the challans issued to violators and the challans uploaded to the Commissioner's Portal, particularly during the period from October, 2024 to 23.01.2025, vide Order dated 19.01.2026.

02. AND WHEREAS, Mr. Abdul Rahim Shaikh filed appeal before the Authority / Chief Minister, Sindh against the said order dated 19.01.2026. The Chief Minister's Secretariat vide letter No.SO(X)/CMS/Appeal/06-16/2026 dated 25.05.2026 has conveyed that the Chief Minister, Sindh / Appellate Authority has converted the major penalty of 'reduction in lower post for a period of one year' imposed upon Mr. Abdul Rahim Shaikh, the then officer of Ex-PCS (BS-17) into minor penalty of 'withholding of promotion for a period of two years' under rule 4 of Sindh Civil Servants (E&D) Rules, 1973. The other part of punishment i.e. he will not be considered for a field position for a period of two years shall remain intact.

03. NOW THEREFORE, with the orders of the Appellate Authority / Chief Minister, Sindh, minor penalty of "withholding of promotion for a period of two years" is hereby imposed upon Mr. Abdul Rahim Shaikh, an officer of Ex-PCS (BS-17) under Rule-4(1)(a)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, in modification of this department's order of even number dated 19.01.2026. However, the other part of punishment i.e. he will not be considered for a field position for a period of two years shall remain intact.

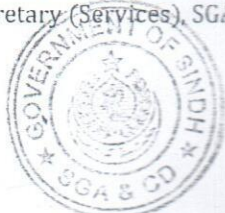
