No.SORI(SGA&CD)Misc-1/2008⁽⁵⁻²⁶⁾: In pursuance of rule 23 of the Sindh Government Rules of Business, 1986, the Government of Sindh are pleased to make the following amendments in the Government of Sindh Manual of Secretariat Instructions, 2014 : -

- 1. In the Instruction 2, after clause (ii), the following new clauses shall be inserted :-**

"(ii-A) "e-Pay Sindh" means the digital payment platform of Government to facilitate the public providing convenient mechanism for receipts collection through digital banking channels including branchless banking services offered by various service providers.

"(ii-B) "e-Services Sindh" means the delivery of digital services by the Departments through e-Services Sindh mobile application and web-portal.

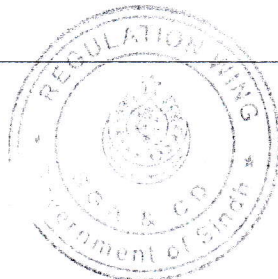
- 2. After the Instructions 35, following new instruction shall be inserted :-**

"35-A, For the disposal of business in the Departments, e-Services Sindh and e-Pay Sindh shall also be adopted in terms of the Instruction 35".

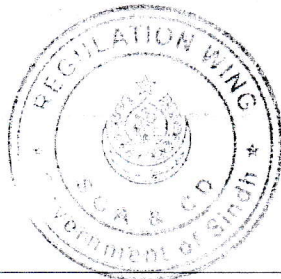
