In Schedule-II, in Serial No. 3, under the heading "BOARD OF REVENUE", after entry at Serial No. 30, the following new entry shall be added :-

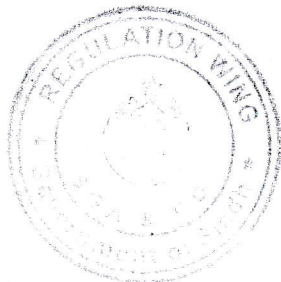

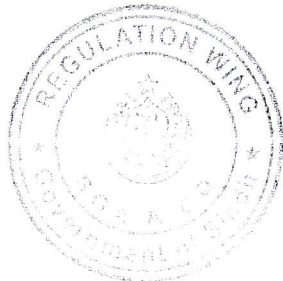
