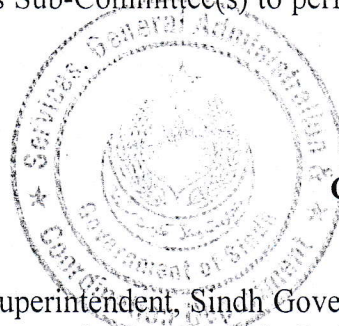

Terms of Reference (TORs)

1. The ACC-I shall exercise its powers and perform its functions as assigned to it under the Sindh Enquiries and Anti-Corruption Rules, 1993.
2. The ACC-I may co-opt member(s) on case-to-case basis, as it may deem necessary for achieving the objectives of the Sindh Enquiries and Anti-Corruption Act, 1991 and Sindh Enquiries and Anti-Corruption Rules, 1993.
3. The ACC-I may constitute its Sub-Committee(s) to perform the functions and duties as may be specified by notification.

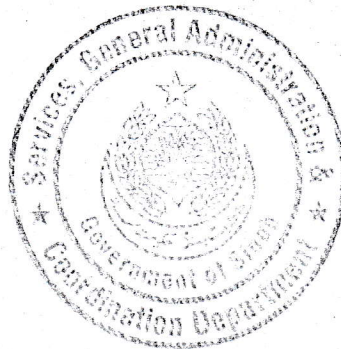
