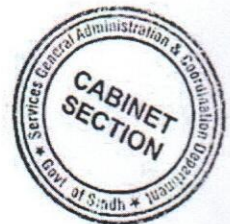

Decision:

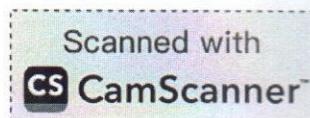
After detailed deliberations, the Cabinet decided that:

- a. Ban on the appointments against the posts in BPS 01 to BPS 04 stands lifted.
- b. The validity of Minutes of Departmental Selection Committees meetings held in pursuance of the advertisements published in the year 2021-22 shall stand extended till 30th June 2026.
- c. Offer letters may be issued to the recommended candidates in the districts where complete and verified record pertaining to the vacant posts of BPS 01 to BPS 04 advertised in the year 2021-22 is available, such as:
 - (i) Copies of advertisements;
 - (ii) Vacancy position duly attested/verified by the Treasury / District Accounts Offices;
 - (iii) Minutes of Departmental Selection Committees duly signed by all members of the DSC;
 - (iv) All prescribed quotas have been followed.
- d. The exercise of issuance of offer letters will be carried out by the respective appointing authorities after completion of all the codal formalities under the existing rules and policies.

- e. In the remaining districts and the districts still having vacancies, fresh recruitment process may be initiated against vacancies (BPS-01 to BPS-04) currently available in their districts in accordance with the existing rules and policies, and as per budgetary provisions duly verified by treasury / District Accounts offices concerned.
- f. Age limit laid down for appointment to the posts shall be relaxed as per rules / policy prevailing at the time of closing date of advertisement of vacancies.
- g. SGA&CD to communicate the decision of the Cabinet to Administrative Departments, Commissioners and Deputy Commissioners.

The Cabinet further directed for the issuance of these Minutes immediately, before the issuance of consolidated Minutes of Meeting of the Cabinet.
