No. SORI(SGA&CD)3-76/2019 :- In exercise of powers conferred by section 26 of the Sindh Civil Servants Act, 1973, the Government of Sindh are pleased to make the following amendment in the Sindh Civil Servants (Appointment, Promotion & Transfer) Rules, 1974:-

AMENDMENT

In rule 5, in sub-rule (1), the existing proviso shall be substituted as follows :-

“Provided that the Departmental Selection Committee in relation to the Tribunal or Special Court established by law or set up by Government shall be headed by the Chairman or Presiding Officer, as the case may be, of such Tribunal or Special Court to the extent of the posts under his subordination, functioning under the respective Administrative Departments with the following composition :-

1.	Chairman/Presiding Officer	Chairman
2.	Special Secretary or Additional Secretary of the Administrative Department	Member
3.	Deputy Secretary (SGA&CD) to be nominated by Chief Secretary, Sindh	Member”.

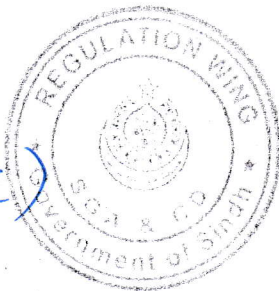
