AMENDMENT

After rule 8, the following new rule shall be inserted :-

“8-A. Complaint, enquiry, investigation or reference received from any other department, agency, authority or court. Notwithstanding anything contained in these rules, any complaint, enquiry, investigation or reference received by E&ACE from any other department, agency, authority or court of law, shall be treated as complaint under these rules, and the provisions of these rules shall apply accordingly thereto”.
